Renewal of Contractual Appointment for the Post of Assistant Teacher

Dear Madam.

We are pleased to renew your position for the post of <u>Assistant Teacher</u> in the St. Ignatius High School, upon completion of your contractual service on 25th March, 2024.

You will be paid a consolidated salary of Rs. 16,680/-, subject to statutory deductions as may be applicable. Your contract for the Academic Year 2024-2025 will begin from 01.04.2024 to 25,03.2025. Your working hours will be from 8.10 a.m. to 3.30 p.m.

You will be required to perform all such duties as are allocated to you by the Head of the Institution and follow all directions given by him/her substitute or any other persons delegated by him/her with powers to issue directions on his/her behalf.

In case of emergency, you avail only 12 Casual Leaves for the Academic Session with prior permission of the School Management by filling the Leave Application form.

Important Points:

- Casual Leave cannot be either prefixed or affixed to a holiday or a Sunday. In that case all including holidays either in between or on either side will be considered as Leave without pay.
- Casual Leave will be forfeited for late arrivals and early departure without a valid reason to school and from school, to be
 calculated from appointed time at the rate of one day's Casual Leave for every three late arrivals and early departure.
- Any unauthorized leave of absence shall entail a deduction in the salary at the end of the Academic Session.
 Leave other than 12 days in a year will be LWP.
- 4. For Medical Leave, Application letter and Doctor's certificate are required.
- 5. No Leave can be claimed as a matter of right.

Being a permanent employee, you shall keep yourself available for the service of the school in any Non-Working/Holiday, if your service is required in an emergency.

Despite the confirmation of service, the school authority will be entitled to terminate you service in such situation, which might appear as contradictory to the rules and regulations of the institution.

In case of your quitting the service, you will be required to intimate the school with one month notice excluding the vacation period or a refund of one month salary, in violation of which, the school will not issue the experience certificate and E.P.F. clearance.

Under any extreme situation, if the school authority is constrained to terminate your service a notice period of one month or a payment of one month salary may be allowed subject to the situation and the underlying issues for termination. The decision of the school authority will be final for such situation.

Corporal Punishment to students is forbidden and is considered a major offence. Any fault from your side may entail termination of services.
